

Magnum Crème Brûlée Kiss Competition T&C's

PROMOTIONAL COMPETITION RULES

The Magnum Crème Brûlée Kiss competition will run on Facebook and Twitter only. The competition will run from 1st September 2016 until midnight on the 31st December 2016. There will be 16x weekly winners and 1x grand prize winner.

The Magnum Crème Brûlée Kiss competition has two competition mechanics:

1. <u>SMS the last 4 digits of the barcode:</u>

- Participants must enter the competition by SMSing the last 4 digits of the barcode found on Magnum Crème Brûlée Kiss packs purchased in order to stand a chance to WIN the grand prize which is an all-expenses paid trip for two to Paris, France.

- Participants can also see a post with the hashtag #ParisPout online, and post their own #ParisPout in response, and automatically be entered into the draw to stand a chance to WIN a weekly French-inspired prize.

DELIVERY OF PRIZE
