“Historically Disadvantaged” for the purposes of this competition is defined as follows:

- Any person who was disadvantaged politically in the past prohibiting him/her from studying or completing his/her studies at a tertiary educational facility
- Any person who was disadvantaged financially in the past prohibiting him/her from studying or completing his/her studies at a tertiary educational facility
- Any person who was disadvantaged physically (sickness or physical disability) in the past prohibiting him/her from studying or completing his/her studies at a tertiary educational facility
