Substance Abuse Agreement

WHEREAS

- A. The Parel Vallei High School (hereinafter referred to as the "School") has adopted a policy regarding the use and possession of various substances.
- B. The parties hereto respectively agree to abide, enforce and promote the rules of the School and standard of conduct set out in this agreement.

NOW THEREFORE THE PARTIES AGREE AS FOLLOWS:

1. USE AND POSSESSION OF VARIOUS SUBSTANCES

The School does not allow students to use, be under the influence of or have in their possession at school or any school associated activities or whilst travelling to or from school or whilst wearing a school uniform or representing the school, namely:

- 1.1 Alcohol;
- 1.2 Tobacco;
- 1.3 Illegal drugs;
- 1.4 Drug related objects and paraphernalia;
- 1.5 Analgesics or medicines excluding only analgesics or medicines currently being used with the knowledge and consent of the parent or guardian of the student in the treatment of an existing condition and in the case of prescribed medicines, upon the prescription thereof.

2. ALCOHOL

- 2.1 The School supports and promotes a responsible approach with regard to alcohol consumption.
- 2.2 Alcohol may only be served at school functions with the prior consent of the principal. Where there is alcohol, non-alcoholic beverages are to be readily available.
- 2.3 Staff and supervising adults are not permitted to drink alcohol during school hours or whilst on duty on school camps or trips.

3. TOBACCO

- 4.3 The inappropriate use of drugs in sport;
- 4.4 The inappropriate use of prescribed and/or non-prescribed medicines;
- 4.5 The sale, supply or exchange of any of the above substances;
- 4.6 The inappropriate use of solvents, inhalants or other chemical agents.

5. ENFORCEMENT

- 5.1 The School supports a positive and supportive approach which will endeavour to modify any inappropriate conduct of the student.
 - 5.2 Notwithstanding the above the School reserves the right, in the case of a breach of any term or condition of this agreement, to:
 - 5.2.1 take appropriate disciplinary steps and apply appropriate disciplinary sanctions;
 - 5.2.2 report any unlawful conduct to the police.
 - 5.3 In the event that the School is of the reasonable view that any breach of the provisions hereof requires treatment or counselling, the student undertakes to submit to appropriate treatment or counselling and the parent/s and/or guardian signing hereinbelow, jointly and severally, undertake to pay for such treatment and/or counselling and the parties hereby authorise the respective treatment institution, therapist or counsellor to furnish the School with progress reports upon request, alternatively and should the said treatment institution, therapist or counsellor fail, refuse and/or neglect to supply the school with such reasonable reports as it may from time to time require, the student and/or parent/s and/or guardian undertake to supply the same to the school.

PERMISSION TO PERFORM PSYCHOMETRIC ASSESSMENTS

Dear Parent(s)

It is customary at Parel Vallei High School to administer aptitude tests / assessments with every child at the beginning of the Grade 8 year and again early in the Grade 9 year. Your child will therefore, together with his / her class, be withdrawn for a full school day in order to complete the battery of tests.

The aim of the assessment is to provide information on various aptitudes of your child to support him / her with academic progress, subject choices and possible career choices. It is further held that aptitude, together with values, interest and other personality characteristics, will to a large extent determine the ultimate success of the child.

It should be stressed that aptitude tests do NOT prescriptively indicate a specific subject choice, course, study direction or occupation for a learner. "Aptitude is the cognitive potential a person has which will enable her / him to achieve a certain level of ability with a given amount of training and or practice" (Owen and Taljaard, 1996).

Aptitude tests provide information regarding a learner's strengths and weaknesses and indicates the learner's ability relative to that of a comparison group, from which certain deductions can then be made.

In **Grade 8** the **General Scholastic Aptitude Test (GSAT) Intermediate Series** will be administered.

The GSAT is a group test constructed to measure academic intelligence or scholastic aptitude. The test can be used as an objective aid in determining the reasoning or problem solving ability of a learner. The GSAT Intermediate Series has been developed for Afrikaans and English speaking learners in coloured, Indian and white schools in South Africa from the age of 11 years 0 months to the age of 14 years 11 months.

In **Grade 9** the **Differential Aptitude Test Form S (DAT-S)** will be administered. The DAT-S assessment is aimed at measuring specific intellectual abilities rather than general intellectual ability. Grade 7 to Grade 10 learners with adequate language proficiency who have been learning in well-provisioned schools will be able to perform these tests.

The above mentioned aptitude assessments will be administered and interpreted by the school's registered Psychologist(s) or under the supervision of the same Psychologist(s). As a parent you have the right to see your child's results. Individual feedback with you and your child will be given in the Grade 9 year. The results of all

aptitude tests will be treated confidentially. The assessment and feedback will be offered free of charge. In order for your child to be assessed the school requires the permission of both biological parents. In the instance where either one or both biological parents are deceased, permission must be granted by the child's legal guardian or foster parent (as appointed by the Court of Law).

Hereby I / we acknowledge receipt of this notice and state that I / we understand the content and the aim of the aptitude tests and therefore give Parel Vallei High School permission to assess / test my child (full names and surname) _____ with the above mentioned tests in Grades 8 and 9 respectively. I / we further agree that the test results of both the Grade 8 and 9 assessments may be discussed with any of the aforementioned or signed parties in this document.
