1. General information

1.1 Submission dates

The deadlines for submission of applications must be strictly adhered to. Applications must be submitted to the relevant Pearson Institute/CTI campus for review and recommendations. The campus Pearson Scholarship Committee will forward the application to the national Pearson Scholarship Committee for final approval. **Application form** to be submitted **to the campus by**: **20**th**January 2017.** No late applications will be considered.

1.2 Qualifying candidates

Applications for bursaries are considered only from South African citizens or individuals with study permits and or permanent residential status who intend to study full time towards programmes on offer at any of the Pearson Institute/CTI campuses. The applicant must meet the minimum entrance requirements for the specific qualification he or she wishes to study and have obtained a senior certificate or equivalent qualification and/or SAQA letter. The application is only for new students who have not previously studied at Pearson Institute or CTI.

1.3 Submitting your Pearson Scholarship application form

Scholarships are awarded on a year-to-year basis and an application has to be submitted every year.

1.4 Process

Application forms with incomplete information will be disqualified. No faxed application forms will be accepted. Read carefully before completing, signing or submitting this form and ensure that this form is completed in full.
