

## **TELKOM 947 CYCLE CHALLENGE BUCKET LIST COMPETITION**

### ***Terms & Conditions***

To participate, enter the Telkom 947 Cycle Challenge by submitting your details in the online entry form, and tell us which destination would be on your bucket list. You need to confirm and pay for your entry by 5pm on 10 April 2017.

Only entries confirmed and paid for between 21 November 2016 and 10 April 2017 will be eligible for participation in this competition.

No free or complimentary entries will be applicable for participation in this competition.

The prize is a bucket list holiday for 2 people, worth R75 000 (seventy-five thousand Rand). This includes flights, accommodation, spending money, transfers, and any additional VISA costs.

The holiday destination will be dependent on the winning entry's submitted destination, but will be booked at the discretion of the Telkom 947 Cycle Challenge committee.
