Prizes

- Only one entrant will stand a chance to win the following prize which is in connection with Absa's sponsorship of the KKNK festival.
 - a. The prize will be 4 (four) tickets to a bespoke VIP show by a top performing artist at the KKNK festival in 2018 to an estimated value of R8 700 (excl. vat). This prize does not include transportation and accommodation costs.
