**PART B DECLARATION****1. I undertake**

- 1.1 to comply with the rules and regulations of the Vaal University of Technology should my application be successful,
- 1.2 to acquaint myself each year/semester with all the rules and general regulations that relate to the residences if I am accommodated,
- 1.3 to inform the residence officer immediately, in writing, if I change my address,
- 1.4 that the completion of this application form and being accepted academically does not guarantee acceptance into the residences, and
- 1.5 that on receiving my letter of acceptance/conditional acceptance from student administration, it is my responsibility as a student to see to it that the residence deposit (as stipulated in the acceptance letter) is paid on registration day to secure my booking. Students must report for registration on the specific day reserved for his/her faculty as communicated to them and advertised in the press. Students reporting late will forfeit their booking,
- 1.6 to vacate my room during University holidays; June and December.
- 1.7 to renew (complete an application form) my residence accommodation every semester/year before or on the due dates for seniors which are:

First semester – 31 March

Second semester and year bookings – 31 August

Failure on my side to renew my accommodation will mean that I forfeit my accommodation in the residences and that I will have no claim in terms thereof. It is then my responsibility to apply for the refunding of my residence deposit.

**2. I hereby accept**

- 2.1 that the Vaal University of Technology reserves the right to adjust the residence fees within the current inflation rate per annum,
- 2.2 and understand that the accommodation only applies to myself. No squatting or sub-letting will be allowed.

**3. I declare**

- 3.1 that should I, during my residence at the hostel, require urgent medical attention, the Residence Officer or his/her replacement is authorised to summon a General Practitioner and/or Psychologist,
- 3.2 that I shall be held liable for payment of all monies owed by myself as a result of my connections with the University,
- 3.3 that in the event that the University instructs Attorneys to take any steps against myself for the recovery of any amounts due to the University by myself, that I shall pay all costs as between Attorney and client, inclusive of collection commission,
- 3.4 that I will inspect my room and residence facilities and that by signing the relevant residence forms I express my satisfaction,
- 3.5 that I conclude this agreement with the knowledge and consent of my parent/guardian/employer,
- 3.6 that all the particulars given by me on this form are true and correct,
- 3.7 that each signatory hereof (be it the applicant, the parent/guardian and/or the spouse) jointly and severally exempts the University and all of its members, functionaries, officials, employees and voluntary workers from all liability and indemnities and holds them harmless against all claims lodged by whomsoever of whatsoever nature and howsoever resulting or arising from the
  - a) loss, illness, death or injury of the applicant; and/or
  - b) loss of or damage to the applicant's property or possessions of whatsoever nature

while he/she is enrolled as a student of the University.
